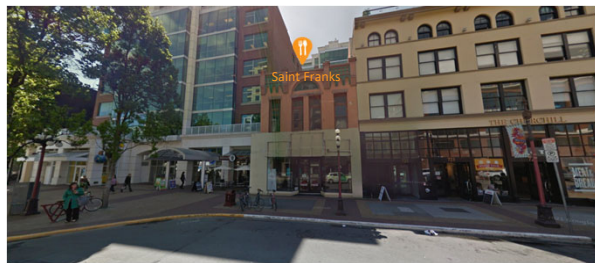
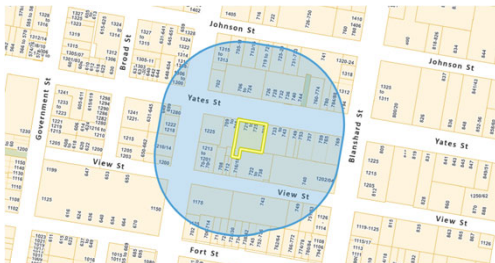

Local Government

- Staff Review
 - Police, Bylaw, Planning, Business and Community Relations and Engineering
 - Zoning regulation, liquor policy and the Liquor Licencing Fee Bylaw
- Public Notification and Comment
 - Notice Posted at entrance to establishment
 - Mailed Notice to within 100m of establishment
 - 30 days to provide comment
- Local Government provides a resolution with comment on:
 - Potential for Noise
 - Potential for Impact on the Community
 - Whether the amendment will result in the service area being operated in a manner that is contrary to the primary purpose

Staff Review and Public Comment

- Staff Review
 - Impacts related to increased hours were not identified
- Public Comment
 - Letters were sent to 869 owners and occupants
 - In response, 33 letters were received – 28 were supportive and 5 were opposed
 - The Downtown Residents Association noted no objection in their letter to Council

Recommendation
