F.1 Bylaw Amendment - Sightseeing Vehicle Parking Stands

Committee received a report dated July 7, 2023, from the Acting Director of Engineering and Public Works, regarding approval to award three parking stand licences each for a two year contract, with an option for a single two year extension, as outlined in the Vehicles for Hire Bylaw.

- 1. That Council direct staff to allocate sightseeing vehicle parking stands 1, 2, and 3 to Wilson's Transportation Ltd, effective January 1, 2024 for a two-year term, subject to entering into agreement in accordance with Schedule E of the Vehicle for Hire Bylaw.
- 2. That the above recommendation be adopted on the condition that, until execution of necessary legal agreements, it creates no legal rights for any person, or obligation on the part of the City or its officials, and any expenditure of funds is at the risk of the person making the expenditure.
- 3. That Council instruct the City Solicitor to bring forward amendments to the Vehicle for Hire Bylaw to:
 - a. Add more sightseeing vehicle parking stands to Schedule D as described in this report; and
 - b. Delegate to the Director of Engineering and Public Works the authority to allocate parking stands in Schedule D based on a competitive process.
