Professional Integrity

As responsible operators, we have successfully undergone a suitability assessment, which involved a series of checks to determine our eligibility. These checks encompassed a scrutiny of criminal records, verified through a criminal record check. Additionally, a police information check was conducted, and our information was examined in intelligence databases maintained by law enforcement agencies. Furthermore, the assessment included a thorough review of our records within the justice information system of the BC Ministry of the Attorney General, as well as an examination of our records within the corrections information system of the BC Ministry of Public Safety and Solicitor General. These steps collectively ensure that the Truffles Group meet the necessary criteria and are deemed suitable to operate a cannabis retail store.



Controlled Sales Experience

Good afternoon.

Please find this letter stating that I, Laura Finnigan of 207-109 Wilson St. Victoria BC V9A 0C4 object to the proposal for the issue of a license to sell Cannabis and other related products at the proposed location of 182 Wilson St. Victoria BC V9A 7N6.

In the past years (I have lived in this residence for 8 years now), this neighbourhood has been allowed to deteriorate considerably with the aid of Victoria City Council and it's current by-laws allowing homelessness to shelter in our city park and the implementation of a shelter on Catherine St.

I have been witness to a female of approximately 25-30 years of age overdosing in front of my building (I waited with her while paramedics arrived), drug paraphernalia strewn within the park and surrounding areas, garbage and litter strewn all around Vic West Park and surrounding areas as well as the considerable drug trafficking and noise.

Not only will a cannabis outlet increase this kind of traffic in this neighbourhood (which is designed for multi family living) but will also encourage the open use of current use (in my opinion).

We, as a neighbourhood deserve to have a safe, enjoyable and liveable area to reside in.

I am 100% opposed to this license.

I am objecting to approval of this application because:

- (1) There already are too many cannabis stores in Victoria West, as well as Victoria.
- (2) Smoke from cannabis contains almost all the same toxins as cigarette smoke. We know that cigarette smoke causes cancer and other diseases in the long run. Why encourage the consumption of another harmful substance? In another 2 decades, the costs to our medicare system from cannabis will be apparent and the question will be asked why did Victoria Council approve these stores?
