## Hello Laura.

This email is to express my support for the proposal to make Lewis Street (with 2 houses exempt) a Heritage Conservation Area.

Lewis Street is a narrow street that is pedestrian friendly. Although it gives the appearance of only single family homes, many of the 15 residences on the street accommodate more than one family. It is an invisible missing middle:

- A home divided up/down with a woman and her husband upstairs and her sister living on the main floor.
- A home divided into 3 suites. There is a long term tenant and several students who live there.
- A home divided into 3 suites. The owner lives in one.
- A multi generational home with one suite.
- A new home with one secondary suite.
- A small suite for a sister-in-law to stay when she works in Victoria.
- A large home with 2 suites. The owner lives in one. A long term tenant lives in another. The main floor is shared by a small group of people.
- A basement suite where a son assists his parents to age in place.

These are affordable living spaces in well maintained homes, a short distance to public transportation and minutes away a bike lane, and from stores and services.

The architecture of Lewis Street's diverse and ranges from the early days of development on the colonial Beckley Farm, through the 1920s and 40s, and one new build in 2023. It is an excellent example of the growth and development of the City of Victoria.

I remain hopeful that Council will approve the bylaw.
