# **PURPOSE**

• To seek Council's approval for the new Major Community Initiatives and Events Grant Program.

#### CONTEXT

- The new Major Community Initiatives and Events Grant Program will
  provide funding to support one-time, new, and unique major community
  celebrations, major destination event hosting, event sponsorships and
  community initiatives which are currently not eligible for other City grant
  programs.
- The total funding available is \$559,170.

### **BACKGROUND**

- During the budget deliberations in early 2024, Council initiated a new Major Community Initiatives and Event fund to support major initiatives that are bold, transformative and move the city forward towards strategic direction laid out in Council's 2023-2026 Strategic Plan.
- Staff reviewed programs from across Canada and propose a one-year pilot program, with maximum flexibility for Council to make decisions on how to distribute funding for community requests.

#### **ISSUES and ANALYSIS**

Based on other similar grant programs researched across Canada, staff recommend the following criteria to be eligible for funding up to 50% of total project operating or capital expenses up to a maximum of \$250,000 cash and/or City services combined per request:

- be a one time, new, and unique initiative or event,
- · must have broad appeal and benefit the community,
- attracts people to Victoria from outside the region,
- prioritize events that occur in the shoulder season,
- have an estimated economic impact greater than \$1,000,000,
- direct cash expenditures greater than \$500,000 with diverse revenue streams,
- · led by entities with a proven track record of delivering large scale projects, and
- gated and ticketed events can be considered eligible provided a significant public free component is included.
