

**BYLAW NOTICE ADJUDICATION BYLAW, AMENDMENT BYLAW (NO. 5)**

A BYLAW OF THE CITY OF VICTORIA

The purpose of this bylaw is to implement amendments to the *Bylaw Notice Adjudication Bylaw* in relation to the *Single-Use Items Reduction Bylaw*, No. 23-013 and remove the discount amount for certain offences.

Under its statutory powers, including sections 260 of the *Community Charter* and the *Local Government Bylaw Notice Enforcement Act*, the Council of the Corporation of the City of Victoria in an open meeting assembled enacts the following provisions:

**Title**

- 1 This bylaw may be cited as the “Bylaw Notice Adjudication Bylaw, Amendment Bylaw (No. 5)”.

**Amendments**

- 2 The *Bylaw Notice Adjudication Bylaw* No. 16-017 is amended as follows:
  - (a) in the table of contents, by inserting the following line immediately after “Schedule G Business Licence Bylaw Contraventions and Penalties”:  
“G-1 Checkout Bag Regulation Bylaw Contraventions and Penalties”
  - (b) in the table of contents, by deleting “Schedule HH Single Use Checkout Bag Regulation Bylaw Contraventions and Penalties” and inserting the following line in its place:  
“HH Single-Use Items Reduction Bylaw Contraventions and Penalties”
  - (c) by deleting the current title to Schedule HH and replacing it with the following and reordering the newly retitled Schedule in accordance with the revised table of contents:  
“G-1 Checkout Bag Regulation Bylaw Contraventions and Penalties”

- (d) by deleting the discount amount under Column B and replacing it with “N/A” for the following offences:
