# TICKET BYLAW, AMENDMENT BYLAW (NO. 16)

## A BYLAW OF THE CITY OF VICTORIA

The purpose of this bylaw is to implement amendments to the *Ticket Bylaw* in relation to the *Single-Use Items Reduction Bylaw*, No. 23-013 and update the fine and discount amount for certain offences.

Under its statutory powers, including sections 260, 264 and 265 of the *Community Charter*, the Council of the Corporation of the City of Victoria in an open meeting assembled enacts the following provisions:

#### Title

1 This bylaw may be cited as the "Ticket Bylaw, Amendment Bylaw (No. 16)".
