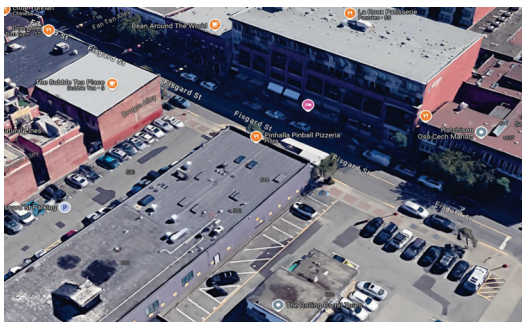
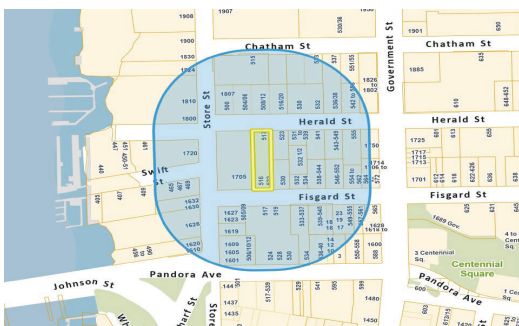

Local Government

- Public Notification and Comment

 - Mailed Notice to within 100m of establishment
 - 30 days to provide comment
- Local Government provides a resolution with comment on:
 - Potential for Noise
 - Potential for Impact on the Community

Staff Review and Public Comment

- Impact Assessment
 - Pinhalla Pinball Pizzeria opened in February of 2024.
 - Storefront has a retractable garage door opening.
 - Business has implemented a policy to close the doors by 10 pm each day and has agreed to reduce the hours originally proposed.
- Public Comment
 - Letters were sent to 862 owners and occupants
 - In response, 12 letters were received – 10 were opposed and two were supportive.
 - A letter from the Downtown Residents Association requested that the hours of operation be reduced as there are residents living in the area.

Recommendation

That Council direct staff to notify the Liquor and Cannabis Regulation Branch that Council supports the application of Pinhalla Pinball Pizzeria, located at 516 Fisgard Street, for a new liquor primary licence with a licenced occupant load of 110 people and revised hours of licenced service that are 9:30 am to 12:00 am Sunday through Thursday and 9:30 am to 1:00 am Friday and Saturday.
