To Mayor, Council, and Sustainable Planning and Community Development Department, Re: Rezoning application for 3198 Quadra Street to rezone to allow a cannabis retail storefront.

I have been a resident and property owner in the Quadra-Hillside area for 13.5 years, and I am opposed to the rezoning of 3198 Quadra St. to allow for another cannabis retail storefront.

There are currently already three cannabis retail stores and a bong shop a short distance away in the Quadra Village. Adding a fourth cannabis retail store to this neighbourhood feels in excess of what is reasonable or needed regarding the density of this type of business. Cannabis/marijuana retail shops are already very well represented in this neighbourhood, with Quadra Street taking on the feel of a "cannabis corridor".

This neighbourhood has a large number of families and young children in the immediate vicinity of 3198 Quadra Street. There are also many schools, daycares and community centres nearby, and the long-term effects of these types of businesses on cities such as Victoria and its respective neighbourhoods may still not be known. Also, it appears that 3198 Quadra street is approximately 200 - 250 meters north of Quadra School (I am familiar with the rezoning requirement of these types of businesses not being within 200 meters). In addition, there has been recent development of a housing site ("Cottage Grove"), by the Cool Aid Society which provides housing for many "at risk" individuals. Many, if not all of the individuals residing at Cottage Grove have suffered from marginalization due to severe mental health disorders, and/or substance use disorders. Many of the individuals residing at Cottage Grove are attempting to continue their recovery, in part, by residing away from individuals or retailers in the down-town core who provide psychoactive substances (such as cannabis). Avoiding potential triggers is an important element of ongoing recovery, and a cannabis retailer in close proximity may undermine the recovery efforts of some individuals.

Seeing further expansion of cannabis retail shops in this neighbourhood would be extremely disappointing and discouraging.
