Good Afternoon,

Thank you for the opportunity to provide comment on the proposed changes to 2695 Capital Heights and the development variance permit application. I live directly across the street from this property (#1-1250 Kings Road) and I would like to provide two comments regarding this application.

Firstly, I commend the City for considering options to increase housing density in this neighbourhood and have zero objections to the proposed infill house.

Secondly, I understand, that there has been some concern raised by property owners in the neighbourhood regarding the City's practice of requiring developers to put in sidewalks. I would like to say that I share the City's views that sidewalks are a key component of developing a walkable City. I am of the view that sidewalks would be a welcome addition in this neighbourhood. Within less than one block of the lot in question there is a seniors' home, a daycare, a small private school, a family housing complex and transition housing for women with families. Within two blocks, there is a large co-op family housing complex. I live in a row of eight Capital Regional District townhouses that faces onto Kings. These eight townhouses alone house 17 children under 12 years old. There are many more townhouses in this complex. Kings is also a pedestrian thoroughfare to Oaklands Elementary and to the shopping district at Quadra and Hillside. For those of us who frequently walk as a means of transportation, for children and for mobility impaired adults, the availability of sidewalks is an equity issue. I would also like to add that because Kings is roughly east/west, at dusk and dawn the sun impairs drivers' ability to see pedestrians walking on the side of the road. At night, the outside edges of Kings between Capital Heights and Mt Stephens are very dark. I encourage you to continue working toward a walkable City.

Dear Mayor Helps and Councillors,

I write as a concerned citizen, living in the "upper Oaklands" area. In particular, my concern is that you are about to mandate the construction of a sidewalk in front of the proposed development at 2695 Capital Heights. A one-block sidewalk would be unsafe and unsightly, especially in light of the broader vision for a greenway.

Wouldn't it be better to give us time to form a greenway plan that takes into consideration the "bigger picture"? As a dog owner, child-minder, senior caregiver, runner, biker and daily after-dinner walker with my husband, I can tell you that drivers on our streets without sidewalks (especially on "upper" Kings, between Fernwood and Cook) seem to drive slower and more mindfully than they do when we're walking on streets with sidewalks. It's as if they seem know they have to keep an eye out for us. In fact, my husband and I bought on Mt. Stephen because it didn't have sidewalks--and that, according to longtime residents, there never would be as a result of the vote they participated in years ago.

It seems to me that the construction of a "piecemeal sidewalk" in front of 2695 Capital Heights will effectively deny us the opportunity to create something more, something of vision, something lasting, in our very special neighbourhood. Please don't proceed with the construction of this sidewalk until a more comprehensive plan can be put into place.
