Greenpeace is campaigning globally to tackle the sources of the plastic pollution crisis in our oceans and end the age of throwaway plastic. We are working to promote a culture of refusal, reduction and reuse instead of our predominant single-use product lifestyle.

Plastic can now be found at every corner of the world's oceans, threatening one of our planet's key life-support systems, harming marine life and even ending up in the seafood on our plate. Plastic washes up on BC beaches regularly and we are ocean neighbours with the North Pacific Gyre or Great Pacific Patch that is a known accumulation an iconic area of the ocean plastic crisis.

We know that single-use plastic bags are a major source of ocean plastic pollution and our use of them globally, in Canada and in BC is highly problematic from a waste management perspective.

Canada exports 1/3 of our plastic waste to other countries, including countries like China, Vietnam and India that are some of the most,afflicted with plastic pollution. We are making our over-use of plastics other countries' problems and there are no guarantees that bags and other single-use plastics are being disposed of or recycled properly either here at home or once they leave our shores.

The only real way to avoid single-use plastic bags in our environment is to not produce them in the first place and embrace re-useable and environmentally and socially responsible alternatives.

Ultimately we need laws to promote closed-loop systems for resource use and materials management, including plastics, but as a first step, governments can take action to ban single-use plastics like bags that have viable and readily available alternatives. More and more jurisdictions are exploring and enacting bans and legislation in an attempt to reduce their single-use plastic footprint and help stop plastic pollution.

We have to stop using the world as if it were a renewable resource. Scientists estimate that in the last 40 years, 52-58% of the worlds wildlife has been lost. At that rate, we will have NO wildlife in 2060. Of course, that loss cannot be attributed to plastics alone but at what point do we as individuals and collectively as a city, start to take responsibility for our behavior and say, "Enough!"

Greenpeace urges the City of Victoria and the Capital Regional District to please join other progressive cities and towns and help end ocean plastics by supporting a bylaw to ban Single-Use Plastic Bags.

As a resident of the City of Victoria, I want to be part of a community which tackles climate change from the inside. A community which drives real change. I spent nearly 5 years working in retail and grocery in my teens. I "double bagged" 2L of milk so it "wouldn't leak in the car". I handed out millions of petroleum products (which are rarely reused and are extremely harmful to our community, waterways and marine life) and listened to customers explain (time and time again) that they had "forgot them in the car". They forgot them in the car because they were lazy, because the system enables that laziness - that casual waste of our resources and environment.

As a coastal community in BC, we have a significant challenge ahead fighting the trans mountain pipeline. I believe our response, as a city and as a province, includes making dramatic changes in our use of petroleum products.

I'm all for the environment. I rarely travel by car. My daily transportation is public transit and my feet. I recycle, consume little electricity, travel little. And I re-use every single plastic bag I acquire.

I am tired of muddle-headed psuedo-environmental initiatives that favour car owners. We used to have curbside collection of recyclable wine and beer bottles, for example. This had many benefits, environmentally, economically, and socially. It created jobs; it meant one vehicle dedicated to collecting all those recyclables. Now, with deposits on these, consumers must return them individually for recycling. In most cases, in their cars! (Imagine lugging a pile of glass on foot to a store or depot miles away, or on the bus.) The change was driven not by the environment, as reported, but by economics. And the result? Jobs lost, and increased reliance on the environmentally diabolic automobile.

Now it's the "war on plastic bags". As Jane Ireland pointed out, people will have to buy 'new' plastic bags for garbage and other purposes, which will be used once only, instead of wisely making second or third use plastic grocery bags. (Which, as Ireland says, are reportedly biodegrable anyway.) And again, reliance on car travel is increased: car owners can easily keep their own large canvas bags in the trunk, and use them whenever they pass by the grocery store. But what are the environmentally conscious users of public transit and personal locomotion supposed to do? Pack around a bunch of bulky canvas bags all day, on foot and on the bus, in case they happen to go the grocery store?

Cars are the major environmental problem. Using public transit is the major solution. Bogus initiatives purporting to be environmental, which in fact favour car owners, are counterproductive.

Get rid of your car, ride the bus, and re-use your plastic grocery bags.

Hi,

I am not in favour of a ban on plastic bags AT THIS TIME for the following reasons:

- Most locals already use reusable bags, rather than ban plastic bags. Continue to EDUCATE people through advertising and marketing. To start the change, perhaps merchants charge 5 cents for a plastic bag, AND offer a 5 cent discount if you supply your own. Money is a big motivator for change.
- 2. People buy more plastic trash bags when shopping bags are unavailable.
- 3. Single-use paper bags contribute more toward global warming than plastic bags.
- 4. Victoria is a tourist town, eliminating plastic bags will cost downtown business in lost sales. Tourists are not going to carry around their purchases in their arms, they need bags to carry their purchases back to their hotels and the cruise ships.
- 5. It greatly reduces the chances of the public "impulse" shopping. Life is busy for everyone in Victoria, working long hours to pay for housing, and while most of our shopping may be planned, sometimes we shop on impulse when it's convenient and we happen to be in a part of town where we need something. For example, when I first moved to Victoria I ended up in the Westshore unplanned and shopped at Superstore in Langford, and only learned when I got to the check-out with my \$300 in groceries that they did not supply ANY bags! I left the groceries, went across the street to Walmart who supplied bags. That cost Superstore \$300, the cashier mentioned this happened a lot, so now they now offer plastic bags for a fee.
- 6. Many major retailers in Victoria offer "FREE PLASTIC BAG RECYCLING" such as Walmart, Thrifty, Save on Foods, Safeway, London Drugs and Superstore. But not many people seem to know about this. ENCOURAGE these retailers to better promote this in their stores and EDUCATE the public (bigger signage, bigger bins, recycling instructions on all plastic bags, cashiers mentioning it when someone buys a plastic bag). Plastic bags can be recycled in to new products, backyard decking, fences, playground equipment, pipes etc.

We all want to reduce our negative impact on the environment and see plastic bags eliminated, but there needs to be a realistic timeline and steps to successfully achieve this.

There are lots of stores that already charge fees for plastic bags, but the fees are not enough of a financial burden that people even think twice about getting them. Superstore has always charged for plastic bags, and I always remember my family just buying however many we needed for that grocery trip. The cost of the bags was never a deterrent for us to not use them because the fee was so small. Shoppers Drugmart already charges for plastic bags but the small fee is not enough for people to not take the plastic bag.

I support a plastic bag ban because that is the only way people will reduce their plastic waste and actually remember to bring reusable bags with them. So many large businesses have already implemented plastic bag bans and it has not affected business. If large companies like Thrifty Foods, Cascadia Liquor, MEC and Whole Foods are able to make the switch away from plastic bags then what are we waiting for?

I work at a personal information that decided to follow suite and we started charging \$0.25 for plastic bags. There were lots of people who would come in and ask for a plastic bag and when told the price, they got extremely angry at us for the fee and took it out on cashiers. There were a lot of people however who still took a bag and in under 2 months we sold over 8000 bags. We then decided to phase out plastic bags and have reusable bags for \$1 instead. I now have no angry customers complaining about the price of reusable bags, they often reevaluate the situation and realize they can fit their purchase in a backpack or purse instead. We also have a lot of regular customers who are bringing back the bag to reuse or are remembering to bring their own bags the next time they come in.

When you were a little kid, brushing your teeth or showering was always a hassle and usually a fight with your parents. But now it is habit and you look back on those days with disgust, like how could you ever think it was ok to not shower or brush your teeth. A plastic bag ban is the same idea, it might take a little bit for you to get in the habit of remembering to bring your reusable bags but after a while you will look back and wonder why you thought you needed plastic in the first place.

This won't be a long message because it's not the most important issue facing our city – compared to homelessness, income inequality and climate change. But..

I don't want the City Council to ban the sale or use of plastic bags. I don't want to make things more difficult for business in our City.

I do favour encouraging, or possible requiring, businesses to charge for each bag they dispense. Save-On Foods added a five cent per bag charge at the checkout, and the cashier I spoke to said that has had a significant reduction in the number of bags they send out the door. It seems silly that an extra 5 cents would make a difference when the groceries to fill it cost \$20 - \$30, but somehow it works. Upping that to 10 cents or 25 cents might work better.

It seems a bit inconsistent to charge for the plastic checkout bags, when I also use plastic bags for produce and bulk foods. Do those not end up in the ocean ? Could you encourage those to be somehow biodegradable ?

If pollution is the concern, I would urge council to look at the Victoria/CRD recycling scheme. There is a pollution disaster. Many households store their recycling outdoors, uncovered.
