Dear Fellow Victorians,

My wife Toshie Kikuta and I, owners of 235 Government Street hope that the proposal for the garage/garden suite be rejected.

As we stated at the James Bay Neighbourhood meeting when the proposal was presented we do not want to lose privacy and light, but above all privacy. There is already a balcony at 229 Government from where the tenants who occupy the top floor of the duplex, can look down into our yard from a height of about 18 feet. If the proposal were to go ahead we would have the occupants of the above ground garden suite looking from the back of229's yard towards our back door. In other words we would have people from two separate dwellings looking down into our yard from the same property and looking at us from two different angles.

And one of those properties is a large duplex with at least one basement room plumbed for a suite. We believe the city is aware of this potential suite.

We also have concerned about parking. There is now 4 cars on this property but room (as it is used now) for three, despite there being a parking space (recently built but not shown on all plans) in the front yard. That means there is one car being parked at all times on the street. A garden suite would see another car or perhaps two put on the street. At this moment Government Street opposite 229 with all the air B+Bs and rental units appearing is FULL. We live next door to 229 Government Street. We see every day who parks where etc.

About us.

We operate our home as a 2 bedroom bed and breakfast. We have one parking spot per room. These are side-by-side parking spots. We serve a complete breakfast and live on site. We call our B and B, Marifield House. We buy a license once a year and have done so for 16 years. We are proud of our small business.

We moved here in 2001, bought the house (C\$260,000) and renovated it and bought furniture (C\$100,000). (Prior to moving here we had lived in a motorhome.) It was a huge cash investment at the time. As well as doing the B+B we enjoy our vegetable and flower gardens and walk Victoria whenever we get the chance.
