Resident profile, accountability and security are paramount in the decision making process.

> Dear Sirs and Madame's. > I am a parent of two children who attended and greatly benefitted from > their attendance at Christ Church Cathedral School. Having had > children that spent the last 6 years at Christ Church Cathedral School > I have noticed a marked decline in the safety of the neighbourhood > since tent city, and now that Mount Edward Court has come into being. > This is a dangerous and unreasonable social experiment to be held 16 > feet away from an elementary school. In the last year I and my 12 year > old child have witnessed prostitution (including acts of fallatio and > sexual intercourse), drug deals and drug use beside the school, in the > church parking lot and in the surrounding area. This is highly > inappropriate and guite frightening for the children, parents and > neighbours. We are an independent school, and the last elementary > school in the down town area. Enrolment is suffering due to this > increased criminal and obscene activity and I really do not see how > this precious gem of a school can continue to exist with such > activities going on regularly next door and in the surrounding area. > Fire alarms, fires and police visits aside, having a low barrier > shelter with a population of people hard to house such as people > struggling with multiple addictions and severe mental health issues > beside an elementary school is a bad idea that lacks common sense and > any kind of urban planning. The building is unfit and unsafe for its > occupants. Perhaps it could be sold and purpose built for seniors or > low income families. We very happily lived with the Seniors home there > and were both good neighbours for many years. The children interacted > on a regular basis with the elderly population and both benefited > greatly from their time together. Now we require a security detail > during school hours to protect our children from the current > population next door. I am disappointed and alarmed that the city has > allowed Cool Aid to house a population of this nature next to an > Elementary School and that Cool Aid now wants to increase the number > of occupants with no previous experience to base the safety of the > neighbourhood on. It is obvious that Cool Aid cares only for it's > clients and not the well being or safety of the neighbourhood, as is > seen at Rock Bay Landing and other Cool Aid facilities around > Victoria. I am very sorry that I will be unable to attend the meeting > on Thursday, July 27 as I will be out of town. I, along with my family > and friends, will be waiting to hear the outcome of this meeting and > we will all be considering all of our options when it comes time to > vote for our city counsellors.
