Annual Membership in Canadian Capital Cities Organization and Attendance at

Annual Conference

Victoria, the Capital City of British Columbia, has historically been represented within the Canadian Capital Cities Organization by the Provincial Capital Commission (PCC). With the recent dissolution of the PCC, Victoria is not currently represented as a member.

It is important that Victoria, as one of Canada's 13 Capital cities, be represented as a member. especially in light of Canada's 150th anniversary in 2017 and the role of Canadian capital cities in celebration of this national occasion. Tourism Victoria has also been consulted and feels representation within the organization is important to support tourism and that Victoria would be the appropriate representative agency.

The CCCO offers two categories for annual membership, and the City of Victoria would most appropriately be served by the Institutional Membership which allows up to five representatives from the City of Victoria to attend CCCO events and would offer the City of Victoria one vote at board meetings and the annual general meeting.

The 2014 Canadian Capital Cities Conference is taking place in Charlottetown, Prince Edward Island, Tuesday, September 2 - Friday September 5, 2014. All Capital cities are normally in attendance and it would be appropriate for the City of Victoria to also be represented by an elected official.

Funds for 2014 membership fees would be funded from Council's budget for membership fees and travel expenses estimated to be \$2,000 for a Council appointee to attend the annual conference would also be funded from this budget in 2014.

Recommendation:

- 1) Council direct staff to join the Canadian Capital Cities Organization as an institutional member and submit annual dues of \$500.
- 2) Council appoint one Councillor to attend the annual 2014 conference in Charlottetown, Prince Edward Island from September 2-5, 2014.
- 3) Council approve travel expenses of up to \$3,000 for Council designate to attend the Canadian Capital Cities Conference.
