Purpose



 Outline and seek Council feedback on the proposed financial plan process



Several municipalities were researched to determine best practices for a new financial planning process.

- A financial plan that clearly outlines services and capital projects, including benefits, costs and revenues of each
- Aligning budgets with priorities where operating and capital budgets flow out of those priorities
- Increased public involvement in the financial planning process
- The financial plan will outline the plans for the coming year; the result of those plans will be reported in the Annual Report

Format

Financial Plan Document



- Visually interesting document
- City of Victoria overview: location, population etc.
- Priorities: once a new strategic plan is developed
- Financial plan framework: legislation and policies
- Overview of departmental responsibilities

Financial Plan Document

Financial summaries

- Operating budgets
 - Description of services
 - Deliverables/metrics that explain the output of each service
 - Benefits of providing each service
 - Proposed changes to service levels
 - Revenues and expenditures for each service
 - Prior year and current year comparison
 - Five-year forecasts
 - Graphs

Capital budgets

- Description of projects
- Rationale and benefits of each project
- Guiding policy linkages where they exist (Official Community Plan, Pedestrian Master Plan, Stormwater Master Plan etc.)
- Revenues and expenditures for each project

Resourcing

- Increase transparency and accountability
- Seek Council feedback on proposed public consultation process and participatory budgeting in October 2014
- Report on participatory budgeting to Corporate and Strategic Services Committee in December 2014

March 2015	Further consideration of the financial plan; 2nd and 3rd readings and adoption of the financial plan bylaw		
March 2015	Consideration of Revenue and Tax Policy
