In my opinion, to deny licensing to the Cannabis Buyers Club would be a travesty. If anything, I would expect them to be given the highest priority of all applicants and even to be used by the city as an example for all other clubs.

To the Mayor of Victoria,

I hope this letter finds you well. Thank you for your time in reading it.

My name is Sebastian Campbell. I am writing you because I recently learned that the rezoning application for the Victoria Cannabis Buyers Club is due for consideration by the city, and that the continued existence of the club may therefore be uncertain. I would like to share my experience as a member of the Club for the last three and a half years, in the hope that it might serve as an illustration of the positive force they represent in the community, and their continued worthiness to remain a part of it.

Five years ago, through no fault of my own, I was struck by a vehicle while cycling home from the University of Victoria. During the collision, I sustained a brain injury, and soon after developed PTSD. In my efforts to cope with and heal from these injuries, it became apparent that the medicinal use of cannabis offered the greatest benefits, with the least amount of side effects. In pursuit of a reliable source of quality medicine, I joined the Victoria Cannabis Buyers Club (VCBC).

I soon found that there are many reasons why the VCBC is exemplary; they provide a safe, discrete venue in which to take one's medicine, at no charge - something the city would otherwise sorely lack. They are a non-profit society; allowing them to offer the best quality of medicine at the lowest cost. They are good neighbours. The staff are compassionate and discrete when discussing personal medical information - more than once have I seen them proactively prevent a Club member from revealing sensitive information about themselves to others. They are also a treasure trove of accurate and relevant information about cannabis, and together possess a rich collection of varied personal experience with the many uses and different was to use it.

However, the thing that makes the Victoria Cannabis Buyers Club unique is the vibrant community that its members have created over the years. The sense of belonging, and acceptance, is something that I have felt keenly every time I visit, and I am truly grateful for its presence in my life.

To deny the rezoning application of the VCBC would be to deny this welcoming, respectful community its focal point - and the health and wellbeing of its members can only suffer as a result. I know mine sure would.

Hello,

I am writing as a neighbor living at 760 Johnson St. I would like to express my opposition to the rezoning of 816-826 Johnson street for a cannabis retail store.

The current available evidence has demonstrated negative effects of cannabis use, with a glaring lack of evidence for the positive health effects often cited by cannabis supporters. In my medical experience, I have seen first-hand the detrimental effect cannabis can have, either directly by causing psychological harm (e.g. worsened depression, worsened anxiety, substance-induced psychosis, delayed frontal lobe development) or indirectly through its use as an alternative to standard therapy (e.g. patients with cancer choosing to use cannabis instead of conventional chemotherapy/radiotherapy).

Several cannabis retailers exist in my neighbourhood, including the newest which opened on Douglas and Johnson. I do not support making this substance more accessible than it already is. To my knowledge, cannabis retailers do not adequately screen for contraindications to cannabis use, including patients who:

- a. are under the age of 25
- b. have a personal history or strong family history of psychosis
- c. have a current or past cannabis use disorder
- d. have an active substance use disorder
- e. have cardiovascular (angina, peripheral vascular disease, cerebrovascular disease, arrhythmia) or respiratory disease
- f. are pregnant, planning to become pregnant or are breastfeeding

Science has shown us the negative effects of Cannabis use and lack of evidence for positive health effects. There are already many "medical" cannabis retailers in the area and we do not need to promote further use unless appropriate controls and education are in place. If this store (and all existing ones) was to open, it would be reasonable to expect the owners to have to display and discuss with customers a full understanding of the negative health effects as outlined below. All buyers should exhibit understanding and consent to the negative impacts.
