Dear Mayor and Council,

Right now in the City of Victoria, we have something unique: a hillside covered by a forest of native Garry Oak and other mature trees on Queen Anne Heights.

Saving our trees is a first priority. Almost every time a new house is built in our neighbourhood a mature Garry Oak tree is removed. Cutting down over 20 trees for the 515 Foul Bay Development to build 3 infill houses is too many lost trees.

According to the staff report "the remaining mature trees on the property, and adjacent, may be negatively effected by the property development." Endangering the remaining trees on our hillside is a travesty. This is an urban forest with a huge canopy that is not replaceable in our lifetimes. Our hillside forms a vital green space conduit between Gonzales Hill and Pemberton Parks for birds and other wildlife.

In spite of multiple requests no protective fencing has been provided around the root zone of our Red Cedar tree #22B.

Blasting is not listed in the current development proposal. However, in the developer presentation to CALUC in August, more of the rock outcropping will be blasted from the site as the proposed method of height reduction used to lower the elevation of house C. The blast area is large and deeper than the original proposal to hoe ram a couple of corners of rock.

This blasting will have to extend out from the house foundation into the east 4 meter setback close to our trees and into the rock outcrop protection zone to the south.

In it's introduction to the neighbours,"No blasting" was used as sales point to promote the development.

More blasting stands to harm our trees.

Re: Proposed development at 515 Foul Bay Road

I think the number of requested variances indicate that they're trying to stuff too many oversized houses onto this property.

The houses are too tall, higher than the McClure Mansion, and an eyesore for the neighbours. Some residents currently enjoying an aesthetically pleasing viewscape of a mature urban forest will have it replaced with a nearly windowless dark wall seven and one-half metres tall. I think it's fair to say the current proposal is incompatible with the existing neighbourhood.

Given increasing demands on Victoria's stormwater system, why would anyone consider approving of a flat roof without requiring a LEEDS green roof? It would help offset the loss of natural ecosystem stormwater services due to buildings, disruption of forest and ground cover, and paving. I strongly suggest that this proposal be required to include this form of stormwater mitigation.

I don't oppose housing but I protest inappropriate and oversized buildings. I wish to emphasize that smaller houses can be heated and cooled more efficiently, and that the carbon savings in constructing, furnishing and living in a small house is significant, and that modest, energy-efficient housing is the only moral choice available relative to the consequences of climate change.

I would support fewer and smaller houses on this property. I'm confident the project can be greatly improved by denying the requested variances and asking the developer to adhere to the bylaws.

Dear Mayor and Council,

I am opposed to the development proposal for 515 Foul Bay Road because of the following reasons: number of housing units on the property, the increase in the height of the buildings, and the reduction in setbacks.

All of these public amenities should not be taken away from the local community and awarded to the developer. Here are the demands for the increases in profit.

LOT A:

- increase the maximum height from 5.00m to 7.50m
- increase the maximum number of storeys from one to two
- reduce the front setback from 7.50m to 1.22m (west)
- reduce the side setback from 7.50m to 3.74m (south)

LOT B:

- increase the maximum height from 5.00m to 7.40m
- increase the maximum number of storeys from one to two
- reduce the front setback from 7.50m to 6.81m (south)
- reduce the side setback from 7.50m to 2.68 (west)

LOT C:

- increase the maximum height from 5.00m to 7.60m
- increase the maximum number of storeys from one to two
- reduce the front setback, from 7.50m to 0.69m (north)
- reduce the side setback from 7.50m to 1.85m (west)

Lot D (Existing House):

- reduce the front setback from 7.50m to 1.58 (west)
- reduce the rear setback from 7.50m to 1.99m (east)
- reduce the side setback from 7.50m to 0.00m (north).

Oak Bay council unanimously turns down proposal to cut down 1 garry oak. Victoria, not likely?

Dear Mayor and Council,

The proposed development at 515 Foul Bay Road is another case of environmental destruction, and building for the ultra rich, with the expectation that requests for zoning changes, variances, and a weak Tree Preservation Bylaw will favour the developer.

It is imperative that the Mayor and Council AND the Planning Department say a firm and final NO to this developer's dream. Citizens of Victoria are well aware that the experiences of Toronto and Vancouver are being repeated here. Affordable rental housing is not available. Overpriced condominiums become empty places, often rented out as Air B & B's while more are built to fill 'the housing supply myth' (see Globe and Mail Sat. Nov. 18/17 Dr John Rose). Owning a home for many is becoming a dream of the past.

To destroy a Garry Oak forest that has been on this hill longer than we know, to blast the rock and destabilize other trees and homes nearby, to build four houses without a care about rules in place that preserve neighbourhoods and a wiser vision of the city is an arrogant act. We must recognize that the time has come to turn away from this idea of privilege and that we can control nature for our own benefit.

More and more of Victoria's tree canopy is being lost to development and in proposed development plans. Will the Urban Forest Master Plan mean little Garry Oaks growing in pots? Is ten years the new age for this old growth species?

I urge the City of Victoria Mayor and Council and Planning Department to say NO to the development at 515 Foul Bay Rd.

Preserve neighbourhoods in the spirit of trust given you, AND make a swift and thorough update to the ineffective Tree Preservation Bylaw.

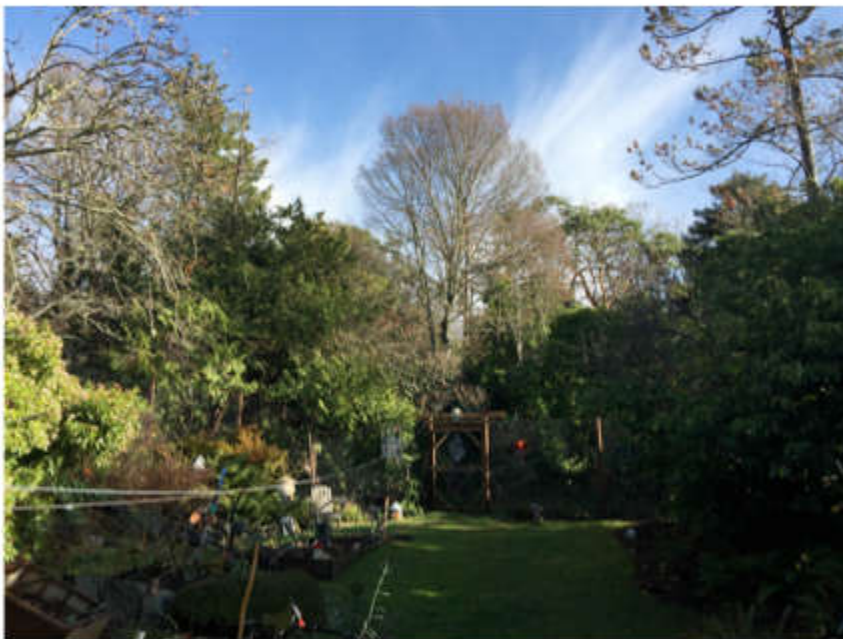
