

A BYLAW OF THE CITY OF VICTORIA

The purpose of this Bylaw is to amend the *Vehicles for Hire Bylaw* to award the west half of Motor Sightseeing Vehicle Parking Stand 3 to The Rolling Barrel until December 31, 2017.

Under its statutory powers, including section 35 of the *Community Charter* and Part 16 of the *Local Government Act*, the Council of the Corporation of the City of Victoria in a public meeting assembled enacts the following provisions:

- 1 This Bylaw may be cited as the “VEHICLES FOR HIRE BYLAW, AMENDMENT BYLAW NO. 18 (17-040)”.
- 2 Bylaw No. 03-60, Vehicles for Hire Bylaw, is amended as follows:
  - (a) in “Contents”, immediately after “11 Amplified music”, by deleting “PART 3 – PEDICABS AND RICKSHAWS” and substituting the following:

“PART 3 – PEDICABS, RICKSHAWS AND PASSENGER POWERED VEHICLES”,
  - (b) in “Contents”, immediately after “29 Special Event Permit Conditions”, by deleting “PART 7 – MOTOR VEHICLES” and substituting the following:

“PART 7 – PARKING MOTOR VEHICLES AND PASSENGER POWERED VEHICLES”,
  - (c) in “Contents”, by adding “and passenger powered vehicles” immediately after “30 Parking motor vehicles”,
  - (d) in section 2, by adding the following new definition immediately after the definition for “park”:

““passenger powered vehicle”

means a human-powered cycle designed for all occupants to power the vehicle;”,
  - (e) in section 2, by deleting the definition for “pedicab” and substituting the following:

“means a human-powered or electric motor-assisted cycle capable of carrying passengers, in which the passengers do not power the vehicle;”,
  - (f) in section 2, by deleting the definition for “rickshaw” and substituting the following:

“means a wheeled passenger vehicle manually pulled or pushed by an operator on foot;”,
  - (g) in section 2, the definition for “sightseeing vehicle” is revised by adding “passenger powered vehicles,” immediately after “including horsedrawn vehicles,”,
  - (h) in section 5(4), by deleting subsections (c) and (d) and substituting the following:

- “(c) pedicabs
  - (d) rickshaws, or
  - (e) passenger powered vehicles.”,
- (i) in section 7(2), by adding “passenger powered vehicle,” immediately after “A person must not transport passengers in a”,
- (j) in section 11(1), by adding “passenger powered vehicle,” immediately after “An operator of a”,
- (k) by deleting the heading for Part 3 and substituting the following:  
  
“PART 3 – PEDICABS, RICKSHAWS AND PASSENGER POWERED VEHICLES”,
- (l) in section 14(1), by deleting “unless the pedicab is equipped with” and substituting “or a passenger powered vehicle unless the pedicab or passenger powered vehicle is equipped with”,
- (m) in section 16(1), by adding “passenger powered vehicle,” immediately after “A person who is operating a”,
- (n) by deleting the heading for Part 7 and substituting the following:  
  
“PART 7 – PARKING MOTOR VEHICLES AND PASSENGER POWERED VEHICLES”,
- (o) by revising the section heading for section 30 by adding “and passenger powered vehicles” immediately after “Parking motor vehicles”,
- (p) in section 30(1), by adding “or a passenger powered vehicle” immediately after “that is a motor vehicle”,
- (q) in section 30(2), by adding “or a passenger powered vehicle” immediately after “that is a motor vehicle”,
- (r) in Schedule D, by deleting the contents of the fourth row in the table relating to “Hippo Tours Inc.”, and substituting the following:
