The size of this proposed project (32 children, plus 6 or 7 staff, plus 32 pick ups and drop offs per day is enormous) is far too large and will negatively impact the surrounding community.

The increased traffic is a major issue that needs to be looked at even more seriously, given that the City of Victoria is implementing a traffic calming project for Montreal Street, and for this block in particular. The absence of on site parking is another major issue, as Montreal Street and the surrounding streets are all residential only and available parking spaces for pick ups and drop offs will be in violation of these rules and are in short supply already.

This project in it's present proposal will create unnecessary conflict and increase the myriad of pressures experienced by this end of James Bay- an area that has more than its fair share right now.
