#### 3.3 Victoria Police Budget update Report

Committee received Memorandum from the Victoria and Esquimalt Police Board dated Jan 4, 2017 regarding cost savings associated with the Victoria Police Budget.

- The size of the Victoria Police jurisdiction versus other jurisdictions.
- The costs of 2 officers, 1 civilians (\$71,908), 4 officers, 2 civilians (\$338,385), and 6 officers, 2 civilians (\$547,626)
- Whether costs would be reduced following regionalization of police services.
- The potential for civilians taking over more paper work from the officers.

It was moved by Mayor Helps, seconded by Councillor Thornton-Joe, that Council allocated \$548,000 from the new assessed revenue to add six new

officers and accompanying civilian staff, subject to Esquimalt Council approval.

- The need for mental health issues being dealt with by public health workers and not police.
