TICKET BYLAW, AMENDMENT BYLAW (NO. 8)

A BYLAW OF THE CITY OF VICTORIA

The purpose of this Bylaw is to establish ticket fines for contravention of provisions in the Parks Regulation Bylaw and Streets and Traffic Bylaw that regulate the use of skateboards and other similar modes of transportation.

Under its statutory powers, including sections 260 to 273 of the *Community Charter*, the Council of the Corporation of the City of Victoria in an open meeting assembled enacts the following provisions:

1 This Bylaw may be cited as the "Ticket Bylaw, Amendment Bylaw (No. 8)."
