
#### **Report to Nominators 2015**

The Victoria Airport Authority (VAA) Board of Directors is pleased to present the following brief summary Report to Nominators. Financial results are preliminary estimates. The formal Annual Report with audited results will be available in April 2016 prior to the Annual Public General Meeting scheduled for May 12, 2016.

#### Passenger Traffic

Year-to-date passenger traffic is up 4.0% as of October 31, 2015, compared to the same period last year, with each month representing record traffic levels.

#### **Achievements**

2015 was a very successful year for Victoria International Airport, with continued strong passenger growth, cost efficiency, significant infrastructure investment to position the airport for future growth, and recognition for environmental, business and customer service excellence.

#### **Highlights**

- Record passenger numbers in each of the first ten months of 2015, with year-end projections expected to be well over 1.7 million passengers.
- For the second time in three years, Victoria International Airport's commitment to providing excellent customer service has earned it the prestigious Airports Council International (ACI) Award for Airport Service Quality. Victoria International Airport ranked first overall for the best regional airport in North America. The CEO accepted the award during the ACI Asia-Pacific Regional Assembly which was held in Dead Sea, Jordan.
- Victoria Airport Authority was awarded 'Business of the Year' (26-75 Employees) by the Greater Victoria Chamber of Commerce, in recognition of its excellence in leadership, innovation and customer service.
- The Air Transport Research Society identified Victoria International Airport as having the lowest cost per enplaned passenger of 12 major Canadian airports studied.
- Victoria International Airport was formally recognized as being the third airport in North America to achieve Carbon Accreditation certification.
- The Airport Improvement Fee (AIF) was increased from \$10 to \$15 in July which had remained unchanged since 2004. The \$15 AIF is still amongst the lowest in Canada and will enable the VAA to meet its future capital obligations.
- The VAA secured a 20 year lease extension with the Federal Government for the airport lands to 2077.
- Victoria Airport Authority secured a two-year license of occupation of the Pat Bay Seaplane Base with the Province of British Columbia, with a view to negotiating a long-term lease with the provincial government.
- The Airport's main apron was expanded to accommodate three additional aircraft for overnight parking which will help facilitate growth. The total project budget was \$8.2 million.
- The VAA entered into an exclusivity agreement with Omicron, one of the largest integrated development, design and construction firms in Western Canada to construct a new commercial retail centre at the intersection of the Patricia Bay Highway (Highway 17), Beacon Avenue and Stirling Way.

#### **Air Services**

- Pacific Coastal Airlines commenced new non-stop service between Victoria and Prince George in January 2015 to provide access to the north.
- Pacific Coastal Airlines commenced twice daily service between Victoria and Kelowna in November 2015.
- Delta Airlines announced new three times daily non-stop service between Victoria and Seattle effective April 2016. This new service will facilitate connections through Delta's worldwide network of destinations from their Seattle hub
- WestJet's subsidiary Encore continued to add service at Victoria International Airport.
   Encore now operates 12 flights per day in addition to WestJet's mainline service.
- Air Canada added an additional Toronto summer service for a total of six flights a day.
- As part of the Western Economic Diversification initiative, the VAA partnered to develop analytical tools to help attract new U.S. air services.
- Several meetings were held throughout 2015 with senior management of potential new low-cost carriers to ensure Victoria forms part of their start-up plans. There are three companies vying to create a low cost airline.

#### **Ground Transportation**

- YYJ Airport Shuttle continued to expand its operations as the licensed hotel shuttle bus contractor operating out of Victoria International Airport. Enhancements were made to its online reservations system and website for an improved customer experience.
- VAA met with the Downtown Hotel Association and Yellow Cabs to create a flat rate fare from the airport to the downtown core. The filing is under development for presentation to the Passenger Transportation Board.
- Construction was completed for a new overflow parking lot west of the Air Terminal Building which will allow additional vehicles to park during peak periods. Plans for an expanded daily parking lot to accommodate additional vehicles are in progress for completion in 2016.

#### **Community Relations**

- VAA maintains a comprehensive public communications program through its Annual Public General Meeting, Airport Consultative Committee meetings, Environmental Committee meetings and Noise Management Committee meetings.
- VAA representatives are active members in a number of community organizations including Tourism Victoria, Greater Victoria Development Agency, Saanich Peninsula Chamber of Commerce, Greater Victoria Chamber of Commerce and Sidney Community Development Committee.
- Updates about Victoria International Airport are communicated through its Annual Report,
   On Approach airport newsletter, website, airmail and social media platforms.
- YYJ launched a new Instagram account (yyjairport) to expand its social media presence.
- VAA proactively met with the Town of Sidney and District of North Saanich to discuss appropriate land use near the airport as it relates to residential development.
- Enhancements were added to the parking lot area for Rotary Park for the direct benefit of the Peninsula Baseball Association.
- An agreement was completed with Tseycum First Nation and the Province of BC regarding a licence of occupation for the Pat Bay Seaplane Base.
- A Request For Proposals process to design and build a military commemorative monument at Hospital Hill was completed and will utilize bricks from the demolished DND administrative building
- VAA participated in a ceremony at the Tseycum First Nation longhouse witnessing an apology from the Province of British Columbia to First Nations around Grace Islet.
- VAA joined the Victoria Conference Centre Advisory Committee.
- VAA held open houses and participated in numerous speaking engagements to share information about upcoming projects, initiatives and events.
- VAA facilitated a number of exclusive behind-the-scenes airport tours for military cadets, preschool groups and service groups.
- Senior airport executives and the VAA Board of Directors participate in several mentorship initiatives with a number of post-secondary institutions to share knowledge and build relationships with future business leaders.
- In cooperation with the Community Arts Council of Greater Victoria and the Art Gallery of Greater Victoria, YYJ's rotating art collection expanded to the Upper Passengers Departure Lounge. A new program entitled 'Love It Want It Have It' provides opportunities to connect local and regional visual artists with potential clients. The art is featured throughout the airport to promote Victoria as a center of artistic and cultural excellence, to provide professional opportunities to local and regional visual artists, and to enhance public spaces.

#### **Customer Service**

- YYJ's Red Coat Volunteers celebrated their 25<sup>th</sup> Anniversary at the airport. VAA's
  dedicated team of men and women were treated to a special luncheon to mark the
  occasion.
- For the second time in the past three years Victoria International Airport was recognized by Airports Council International as the best regional airport in North America for service quality. The award was presented at an international event at the Dead Sea, Jordan.
- New Ali Ficus trees were added throughout the terminal building to add green space and to complement many improvements in seating and waiting areas in public spaces and departure lounges.
- Customer service enhancements were added to the family room, fireside lounge, rotunda meeting area and pre-board screening which included a 270 ft<sup>2</sup> photo mural of Francis King Park.
- Four new benches were added to the Flight Path multi use trail around the airport for the users to enjoy.
- New electric vehicle charging stations were added to the parking lots.

#### **Donations and Sponsorships**

- In lieu of sending out holiday greeting cards, VAA collected non-perishable food items and cash donations for donation to the Sidney Lions Food Bank, Mustard Seed Food Bank and Victoria Hospice Society.
- The VAA Board of Directors matched employee contributions to the United Way of Greater Victoria which is expected to total approximately \$8,500.
- VAA contributed an additional \$56,360 toward various charitable causes and community events through donations and sponsorships, which are noted on the following page.
- In summary, VAA forecasts the 2015 charitable contributions to total \$64,860.

#### **Events at YYJ**

- In January, Victoria International Airport hosted the annual Santa Shave For Hospice, raising funds and awareness for Victoria Hospice Society.
- Ribbon cutting ceremonies were held to celebrate route launches for Pacific Coastal Airlines' new service to Prince George and Kelowna.
- An airport tenant appreciation lunch was held to mark the occasion of YYJ's Airport Service Quality Award win, and to thank all airport tenants for their contributions in making the award possible.
- Victoria Airport Fire Services participated in the Victoria Day parade.
- VAA presented at 'PrepAIR', a full day seminar held in partnership with NavCanada designed to educate general aviation pilots about flight safety and procedures at Victoria International Airport.
- VAA staff volunteered their time to give tours of a number of airport vehicles to the public at the annual 'Touch A Truck' fundraiser for pediatric cancer.
- In August, the Victoria Flying club welcomed the 'Sentimental Journey', a World War II B-17 bomber offering public tours of the historic aircraft.
- Pacific Sky Aviation hosted the Canadian Forces Snowbirds as a fundraiser for the C.H.I.L.D. Foundation.
- In August, the Vancouver Island Motor Gathering was held at Viscount Aerocentre.
- In September the post-secondary institutions set up greeting booths to welcome new students to the city.
- VAA participated in the 'Team 4 Hope' 50K Goose Relay and Ultra Marathon, winning the first place medal.
- YYJ welcomed Air Transat's wide body A330 aircraft for a special charter flight.
- The VAA's Christmas music program ran through the holidays where a variety of musicians and choirs entertained our guests

#### **Safety and Security**

Safety and security are the highest priorities for the Victoria International Airport.

- In 2015, the project to enhance CCTV camera coverage was expanded to include more outdoor cameras in the parking lots and maintenance yard.
- Victoria International Airport began work on a \$9.7 million CATSA-initiated project to update its checked baggage screening capabilities to comply with international standards and replace aging equipment.
- Planning for the new Transport Canada-mandated Non-Passenger Vehicle Screening facility got underway for an April 1, 2016 implementation.
- Ice alert indicators were installed along The Flight Path VAA's 9.3 km multi use path around the terminal building to forewarn the public of potential freezing conditions on walkways.
- Human Factors training, which focuses on the interaction between humans and systems, was provided to all staff and was extended to contractors acting on behalf of the VAA.
- A Program Validation Inspection was completed by Transport Canada which focused on the airport's Safety Management System.
- An extensive review of all incidents and hazards recorded in the VAA's reporting system
  was completed. This resulted in four primary safety specific goals for focus on in 2015.
  Objectives included reduction of runway incursions, reduction of bird strikes, reduction of
  safety issues on commercial aprons and reduction of foreign objects and debris (FOD).
- An awareness campaign was introduced to airport tenants focusing on the impacts of FOD on aircraft operations.
- A number of safety auditing procedures were developed to enhance the quality of VAA's safety program.
- A new Manager of Safety and Emergency Services was recruited due to a staff retirement.

#### **Environment**

The Victoria International Airport continued to maintain a leadership position with respect to environmental stewardship.

- Victoria International Airport was the third airport in North America to achieve Airports Council International's Level 1 Airport Carbon Accreditation.
- Annual tenant environmental compliance audits were completed.
- VAA completed a TenTen Creek preliminary bank stability assessment and project plan for 2016.
- VAA completed significant sediment removal work in TenTen Creek.
- In addition to many smaller fish, a large cutthroat Trout was discovered in TenTen Creek which confirms that trout from the ocean are once again returning to the creek.
- There were no glycol exceedences in Reay Creek or violations of the CRD discharge permit for glycol.
- A Stage 1 environmental assessment of Pat Bay Seaplane Base was completed.
- VAA hosted Transport Canada's air quality monitoring truck.
- Preliminary design work for a detention pond system at Reay Creek was completed which is intended to reduce peak storm water flows.
- VAA is actively participating in the Reay Creek Pond Technical Advisory Group which has a mandate to assess the pollution continued within the pond.

#### **Airport Operations**

- The Operations team is responsible for keeping the runways clear, inspecting and repairing equipment, maintaining the airport grounds and terminal buildings, maintaining VAA's fleet and ensuring compliance with Transport Canada's safety requirements.
- VAA invests in various mandatory and development training opportunities for employees.
   Some of the training completed in 2015 by the Operational Team included:
  - Airport Wildlife Control
  - Aircraft Movement Surface Condition Reporting
  - Annual Live Fires
  - Airfield Lighting Systems

- Phase 3 of a multi-phase airfield power distribution system was completed to upgrade the electrical system.
- A 17,000 m<sup>2</sup> expansion to the main commercial apron began in the fall of 2015. The
  expansion will provide parking for up to three large aircraft as well as a glycol collection
  system.
- A new airfield sweeper truck was purchased to replace an older unit at the end of its life cycle.
- VAA replaced its aging public address system in the terminal building.

#### **Land Development**

- VAA announced an exclusivity agreement with Omicron for a potential new commercial land development near the intersection of Beacon Avenue and Highway 17 (Pat Bay Highway).
- Pacific Sky Aviation and Viking Air announced a new Twin Otter flight simulator facility.
- Seastar Chemicals announced the construction of a new building.
- Scott Plastics announced plans to expand their facilities to include a new building.
- 443 Maritime Helicopter Squadron moved its administrative offices into the new hangar facility 'Arundel Castle'.
- Mifco Inc. (Global Remote Sensing) installed a new solar panel array on their building.
- VAA completed updates to its Land Development Guidelines and a new tenant resource section was added to VAA's website.

### Financial Highlights (Projected 2015 Results)

Attached as Appendix 1 is VAA's unaudited 2015 Forecasted Statement of Operations.

#### Highlights

- At \$15, Victoria's AIF remains among the lowest for Canadian airports in the National Airports System.
- The Air Transport Research Society identified Victoria International Airport as having the lowest cost per enplaned passenger of twelve major Canadian Airports studied.
- Total revenue for 2015 is expected to be 11.0% higher than 2014.
- Excess revenue over expenses before amortization improved 18.4%.
- Year-end long-term debt was reduced by \$1.8 million to \$2.25 million.
- Non-aeronautical revenue was 66% of total operations revenue which represents the highest percentage of the major airports in the country.

#### Rent to the Federal Government

- In 2015, VAA paid approximately \$1.1 million to the Federal government.
- The rent formula is a sliding scale with rate increases similar to income tax.
- VAA is currently in the 8% marginal rent bracket which applies to annual gross revenue over \$25 million. Each incremental dollar of revenue attracts rent of \$0.08.

#### **Capital Program**

Over \$139 million has been invested in capital improvements to the facility since the Victoria Airport Authority took over operations of the Victoria International Airport in 1997.

Attached as Appendix 2 are the Capital Program 2015 Forecast and 2016 Capital Program Plan.

#### **Board of Directors**

The Board of Directors provides oversight to the Victoria Airport Authority to ensure its purposes and objectives are realized, and that YYJ operates in a safe, efficient and reliable manner.

Attached as Appendix 3 is a summary of the VAA Board of Directors and Committee Participation for year 2015.

Explanations for projected noteworthy variances from above include:

- 1. Increase in passenger volumes has led to improved parking, restaurant and other concession revenues.
- Result of increased passenger traffic and the adjustment to the AIF from \$10 to \$15 per passenger as of July 1, 2015.
- 3. Rent expense is paid to Transport Canada as a percentage of revenue the projected increase reflects projected increases in revenue from both the AIF and other areas shown above.
- 4. The AIF handling fee represents a 7% fee paid to the air carriers to collect the AIF as the AIF revenue increases, the handling fee increases accordingly.
- 5. Reflects a projected increase in capital assets.
- 6. Long-term debt has been reduced by \$1.8 million in 2015, which reduces interest expense.
