Dear Minister Fassbender,

I am writing to express my profound concern about how the \$5010.47 property tax bill assessed for 941 Kings Road, Victoria BC has somehow been deferred for the first time in 30 years to the British Columbia Schizophrenia Society (BCSS), Victoria Branch for payment. We have come to understand that this was made possible by section 224 of the *Community Charter* that permits property tax exemptions for non-profit organizations.

Our Executive Board and I are dismayed that our small non-profit is somehow responsible for paying property taxes on a building we do not own but simply lease. While section 224 of the *Community Charter* was no doubt conceived with an altruistic purpose in mind, it ultimately benefits non-profit organizations that are either wealthy enough to own property or were simply fortunate enough to have property donated to them. The benefits of section 224 are at our non-profit organization's expense.

While moving seems to be the most obvious solution for a flexible and resilient organization like ours, the vast majority of our clients encounter great difficulty feeling comfortable or safe in environments outside of their home. Moving is not an option for us as it would cause a significant disruption to our service delivery model and our client base.

One in five people face mental health issues in Victoria. For those with mental health issues, 1:100 live with schizophrenia, 3:100 live with bipolar, 3:100 have major depression, and 3:100 live with psychosis. Psychosis is seen most often in youth 14-25 years of age. BCSS Victoria works hard to assist individuals with mental illness access appropriate support, and provides services and support for their caregivers. This new \$5010.47 tax will impact our current and future client base because we will be compelled to cut services for approximately 45 people with serious mental health concerns. Our services increase our clients' self-management skills and have a measurable effect in diminishing calls to emergency services including the police, visits to the hospital, and general social services system burden.

We are the foremost non-profit in Victoria for mental health service provision; this is reflected in the number of referrals we receive from the Vancouver Island Health Authority. I am sure you can appreciate how cuts to social service providers like BCSS Victoria – whether they come in the form of decreased funding or increased taxes –

have a downstream effect of reinforcing existing systematic problems in the City of Victoria that contribute to homelessness, violence, and poverty.

We formally appealed to the City of Victoria in June 2015, but to no avail. We understand that mental health services are one of the top concerns of the Province of British Columbia as per the Minister of Health's announcement on October 10, 2015.

Please level the playing field and amend the *Community Charter* to ensure that organizations that are eligible for property tax exemption cannot defer their property taxes to non-profit organizations that provide front-line social services.
