

A BYLAW OF THE CITY OF VICTORIA

The purposes of this Bylaw are to amend the Zoning Regulation Bylaw by creating the R1-A-18 Zone, Rockland Ashton District, and to rezone the land known as 1745 Rockland Avenue from the R1-A Zone, Rockland Single Family Dwelling District, and R1-B Zone, Single Family Dwelling District, to the R1-A-18 Zone, Rockland Ashton District.

The Council of The Corporation of the City of Victoria enacts the following provisions:

- 1 This Bylaw may be cited as the “ZONING REGULATION BYLAW, AMENDMENT BYLAW (NO. 1053)”.
- 2 Bylaw No. 80-159, the Zoning Regulation Bylaw, is amended in the Table of Contents of Schedule “B” under the caption PART 1 – Detached Dwelling Zones by adding the following words:

“1.128 R1-A-18, Rockland Ashton District”.
- 3 The Zoning Regulation Bylaw is also amended by adding to Schedule B after Part 1.127 the provisions contained in Schedule 1 of this Bylaw.
- 4 The land known as 1745 Rockland, legally described as Lot A Section 74, Victoria District, Plan 36329 and shown hatched on the attached map, is removed from the R1-A Zone, Rockland Single Family Dwelling District, and R1-B Zone, Single Family District, and placed in the R1-A-18 Zone, Rockland Ashton District.

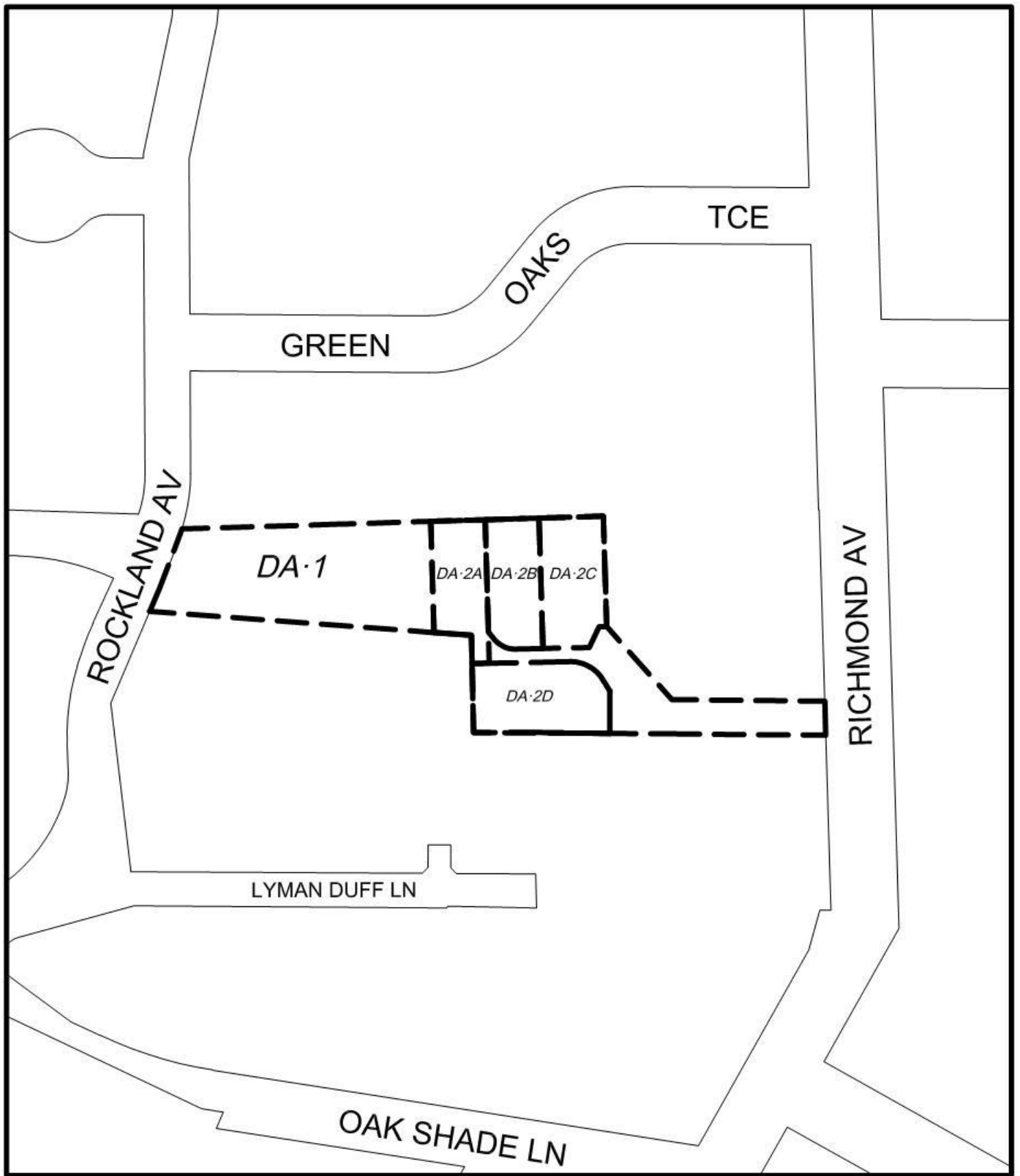
