Hello my name is Tristan Ray-Wilks. I am here to address the concern of plastic pollution we are continuing to produce in Victoria. I work on the water as a wildlife guide and for all the beautiful things I see, I'm also exposed to just as much of the complete opposite. I'm primarily speaking in regards to plastic pollution. What concerns me the most is the irresponsible use of single use plastic bottles, cups, coffee lids, straws, balloons and plastic bags.

While on a trip taxiing in or out of Victoria harbor, I generally come across plastic bags. To be more precise, sandwich bags, large black garbage bags, and tons of single-use grocery bags. I do what I can to pick out all that I come across, and I have done this so often that I've got retrieval so flawless to which I no longer have to completely stop my boat. However, there are **also** those that are just too deep in the water to reach.

This is where things become much more complicated. Not only are these bags leeching petrochemicals into our oceans, aiding in ocean acidification, but also they are mortally detrimental to marine and terrestrial life. Being on the water I am engaged in conversations with people of various environmental backgrounds, and often hear of yet another whale, sea-lion, or other animal that has died from plastic bags. I have personally seen what a plastic bag can do to bird when it has ingested it as food.

I would like to do a quick slide of pictures of some things I have retrieved, some of which I have recovered in the hundreds.

At home my partner and I use %100 percent biodegradable plastic bags. Not only are they offered for sale by the City of Victoria, they are at an unbeatable price (which, if you're curious is 90 bags for \$10). That's 9 cents a bag, which is a trivial cost for something that we all should feel morally obliged to use.

In addition to being a wildlife guide I'm also on the board of Cetus Research and Conservation Society. If any of you are interested in what we are doing to protect our local waters, I would love to speak with you. Feel free to approach or contact me. In conclusion I would like to stress how immediate banning the single use plastic bag should be. I'd like to think that we are at a level of sophistication where Victoria takes the lead in phasing out the single use plastic bag and eventually all irresponsible plastic products.
