Subject: petition opposed to BlueSky/Bosa plan for St. Andrew's

To mayor and council,

Attached is a copy of a petition with 436 signers that was presented to council at the August 28, 2014 meeting. The petition opposes the BlueSky/Bosa development plan for St. Andrew's because of the excessive size of the building; shadowing on Mason Street for residences and the City Farm; poor transitioning into the North Park neighbourhood; routing all traffic onto Mason; the very large anchor tenant retail space; and the lack of amenities, like green space.

Also attached is a copy of a further 617 names collected from September 2014 to August 19, 2015. We are submitting it electronically now so that it can be included in your agenda package for the August 27, 2015 public hearing. The original petition will be presented at the public hearing.

To date, that adds up to more than 1,050 signatures collected in opposition to the plan, and more are still coming in. Over the past two years of collecting these signatures, the developer has made no significant changes to the key elements identified as concerns, even though the developer's reason for postponing the September 11, 2014 public hearing was to do just that. The concerns are as valid today as they were two years ago because, while there have been some shifts (height reduction from six to four storeys on Mason and the park, 11 out of 210 units designated "affordable housing," anchor store reduced from 37,000 to 35,000 sq. ft.) the key concerns noted above remain.

This plan does not fit with the neighbourhood's vision of appropriate development for this site and sets the bad precedent of imposing the developer's interests on a neighbourhood with little or no regard for any concessions or community-building amenities. We hope you will appreciate that a significant number of residents and businesses are unable to support it and that you will turn it down.
