## What is ABE?

- Three basic categories of students:
  - 1. those seeking to complete their high school studies
  - 2. those seeking to upgrade their high school courses
  - 3. those seeking to improve basic literary or numeracy
- Students with developmental disabilities enrolled in adult special education programs
- English as a second language students



## **ABE** students

- ABE students are some of our most marginalized groups
  - 58% are women
  - 18% are Indigenous people
  - 20% are parents during their studies
  - 55% are employed while studying
  - 79% have already graduated from high school
  - 70% continue their studies after ABE

## Changes to ABE

- In December 2014: the provincial government announced a \$15 million funding cut
- January 1, 2015: Institutions enabled to charge tuition fees on previously cost-free ABE courses with less than one month's notice to students
  - Fee cap set at \$1600 per semester (\$320/course) for all adult upgrading courses
- May 1, 2015: government will no longer fund school districts for tuition-free upgrading courses for adults who already hold a high school diploma
- May 1, 2015: some increases in grant money for ABE students

"We are helping people upgrade their education so they can take advantage of our growing economy and enjoy rewarding careers... by offering free tuition for adult basic education, whether students have graduated from high school or not."
